I assume all risks associated with running/walking in this race, including, but not limited to, falls, contact with other participants, the effects of the weather including high heat and humidity, and the conditions of the road, all such risks being known and appreciated by me. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I for myself and anyone for whom I am entitled to act, waive, release, and will hold harmless HARD, the race organizer, all other sponsors, and all the agents, employees, officers, directors and volunteers working for those entities from all claims and liabilities of any kind arising out of or related to my participation in this race. I understand that headphones, roller skates and dogs are not allowed in this event unless explicitly authorized by the race organizer.

I have carefully read the description of the above event for which I/we are registering and inconsideration for being permitted by the Hayward Area Recreation and Park District to participate in the "10K on the Bay" activity, I hereby waive release and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns.
